The Club is a place where children from the community and surrounding areas are not left behind and are given every opportunity possible to hope, dream and achieve their goals. For 73 years the Grenville Baker Boys and Girls has been committed to providing a secure and encouraging space where members can come after school and be surrounded by positive role models, mentors, and staff.

- In early 2022 during the February break, members were able to return to visiting college campuses. These tours were extra special as they were led by Club alumni. Members visited SUNY Binghamton with a tour from Joe Valli, University of Buffalo with a tour from Emerson Ronquillo, SUNY Geneseo where Stephanie Moran showed them around, Ithaca College where they met up with Jimmy Mejia and SUNY Cortland with a tour from Camilo Fredes. In addition to an official campus tour, these tour guides were able to provide close and personal feedback about their experiences at these colleges.
- One of many program highlights from the past year was a visit from the Safe Center who spoke with our 5th graders about a topic very much on parent's radar- internet safety, cyberbullying, and how social media can have a negative impact on young kids. The material was relevant in their lives and the fifth graders were deeply engaged in the content. Members were left with a good understanding of the effects cyberbullying can have and when to let an adult know of any uncomfortable situation that may be occurring on a video game, text message, or any other social media platform.
- We recently named our 2023 Youth of the Year, John Cruz. Every year our Club selects a member who embodies the values of leadership, community service, academic excellence, and good character. John, who has been a member of the Club since Kindergarten, exemplifies these qualities. John credits the Club with helping him prioritize homework over ping pong but most importantly as a member and Treasurer of the Keystone Club he acknowledges the tremendous impact he and his peers have made through their community service. "To make the slightest difference in the community makes you feel good about yourself," said John. We have watched John grow into a responsible young man and have no doubt he will continue to make us all proud as he moves forward.

## CLASS OF 2022



Mike and Maria Maroni

Maria Maroni is the owner of Maroni Cuisine in Northport, continually ranked among the best restaurants on Long Island since its opening in May 2001. Created with her late husband Mike, in 2007 their signature meatballs were featured on an episode of the Food Network show "Throwdown" with Maroni's meatballs being judged the winner over those of chef Bobby Flay. Maroni's meatballs have also been featured on the Martha Stewart show and the Today program. Mike and Maria's first restaurant, Mirepoix, was also a critically acclaimed success when it was opened in Glen Head in 1997. In addition to Maroni Cuisine Maria currently owns and operates Maroni Cuisine Southold on the North Fork of Long Island.

A native of Locust Valley, Mike was a self-taught chef who was cooking since age 16 at a variety of restaurants. He was an alumnus of the Grenville Baker Boys and Girls Club where camping trips to Canada that featured campfire cooking helped develop his love of feeding others, and remembered those trips as some of the best experiences of his life. Maria has been in the restaurant business for most of her life, meeting Mike when they worked together at a restaurant in Oyster Bay. They married in 1995, and together raised their nephew Branden since he was a young child. Over the years Mike and Maria assisted with the Club's Annual Thanksgiving Dinner, conducted cooking classes for Club members, and hosted many events for generous benefactors of the Club. Mike passed away in March 2019, and the Club's Maroni Kitchen is named in his memory.

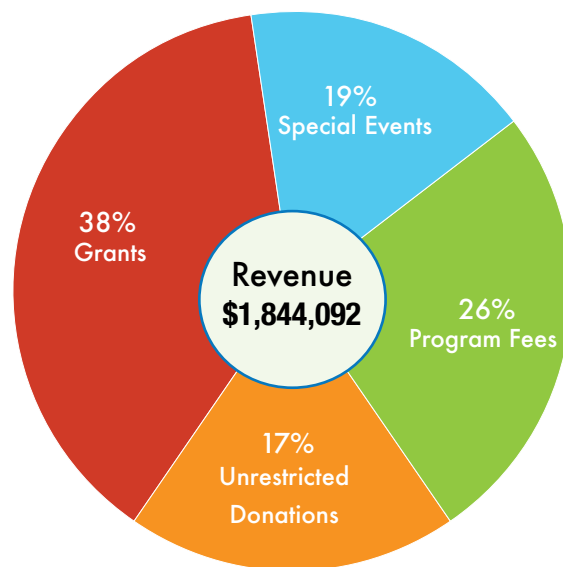

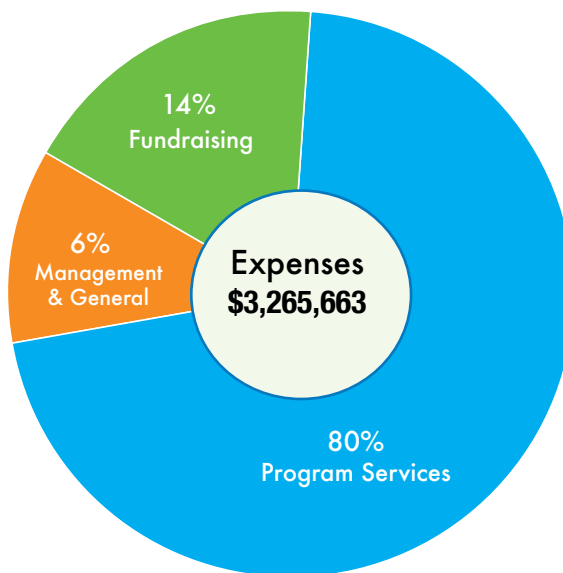
