Dear Friends,

As we reflect on the past year at Grenville Baker Boys & Girls Club, we are filled with immense gratitude and pride for the strides we have made together. This year has been one of growth, impact, and unwavering commitment to our mission to inspire and enable all young people to realize their potential as productive, responsible and caring citizens and community leaders of tomorrow.



Some of our accomplishments over this past year include:

- We happily partnered with New York Institute of Technology to host an Art Show and Immersive STEM Experience in February to benefit Love Without Borders, a non-profit organization that helps refugee families relocating to Greece. Our Keystone Club was so inspired by their work that they decided to raise funds starting in September 2023 to travel to Greece in 2024 to work directly with the families.
- We graciously accepted a grant from Apple to host a digital art program called Everyone Can Create. Youth captured video footage from the community to create a PSA that was showcased at the 2023 National Keystone Conference in Dallas.
- We reignited the wildly popular 3-on-3 Basketball Tournament in March 2023. 117 players participated and over \$12,000 was raised thanks to the hard work and tireless commitment of a wonderful and dedicated committee.
- We enhanced our program offerings this year to include an academic intervention program facilitated by a certified teacher, a National Hockey League sponsored floor hockey program, yoga and meditation, family fun nights, and a flight simulator program.
- Our tried-and-true programs such as our K-5 Enrichment Program, Basketball, Keystone, College Prep, Gymnastics, and Summer Camp continue to grow in number of youth served as well as in impact and quality of service.
- We hosted several events that connected the community to us, including alumni events, Guest Bartending Night, Summer Soiree, Pickleball, and our first annual All-Star Basketball game in partnership with the City of Glen Cove.

While we are proud of our achievements, we recognize that there is still much to be done. As we move forward, our Club's priorities will align to Boys & Girls Clubs of America's strategic direction, Future Ready, and will include:

- Enabling all young people to achieve positive outcomes in our three pillars: Learning and Innovation, Health and Well-Being, and Future Readiness, through our creative and high-quality programs and experiences.
- Expanding our reach to address the unmet demand for our services while retaining and deepening engagement with our current members.
- Engaging with our supporters to cultivate a vibrant and active network of advocates for our mission.


