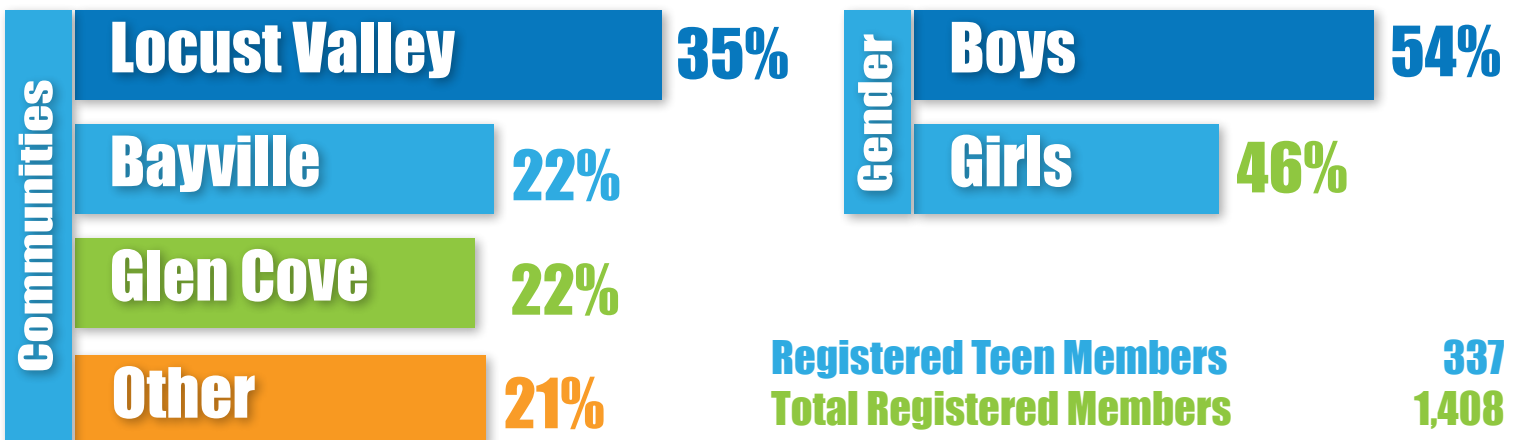

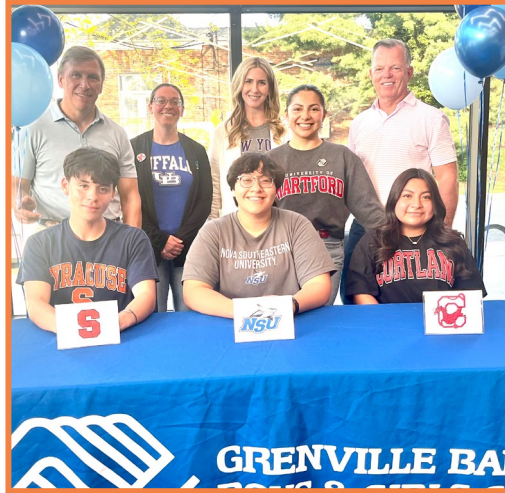

Keystone Service Trip

Keystone is a community service and leadership program for high school members at the Club. Over the past year, these dedicated teens supported nearly every major Club event, including the Pancake Breakfast, Thanksgiving Dinner, and the Day for Kids Carnival. They also organized a Culture Fair and volunteered with local organizations such as soup kitchens and the Miracle League.

Keystone members took their commitment to service to a global level by traveling to Athens, Greece, to volunteer with refugee families from Syria, Iraq, and Afghanistan. In partnership with the organization Love Without Borders, they provided educational workshops, art therapy, and emotional support to displaced children and adults.

The experience was both humbling and transformative. The members demonstrated maturity, compassion, and leadership as they embraced this opportunity to make a meaningful difference. Their work abroad reflects the true spirit of Keystone—service, leadership, and a desire to build a better world.

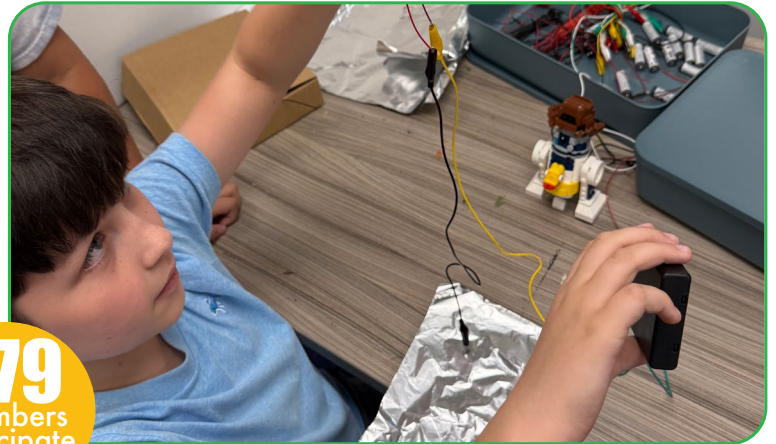

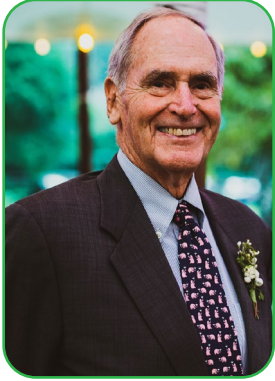

William “Bill” Hinckley Award

Named in honor of the Club’s first Executive Director, the William “Bill” Hinckley Award is given annually to a Club staff member who has demonstrated a commitment to the Club, its members and their families by consistently performing at a level of excellence.

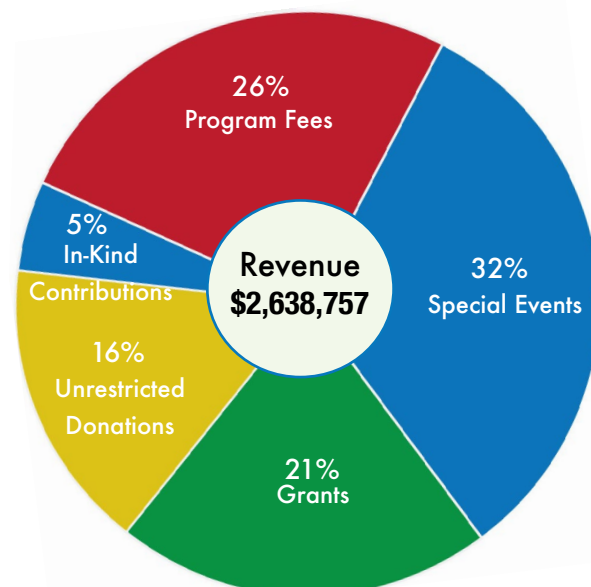

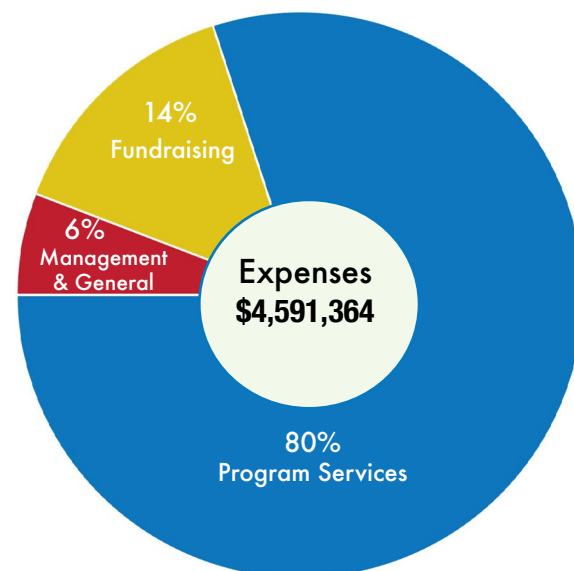

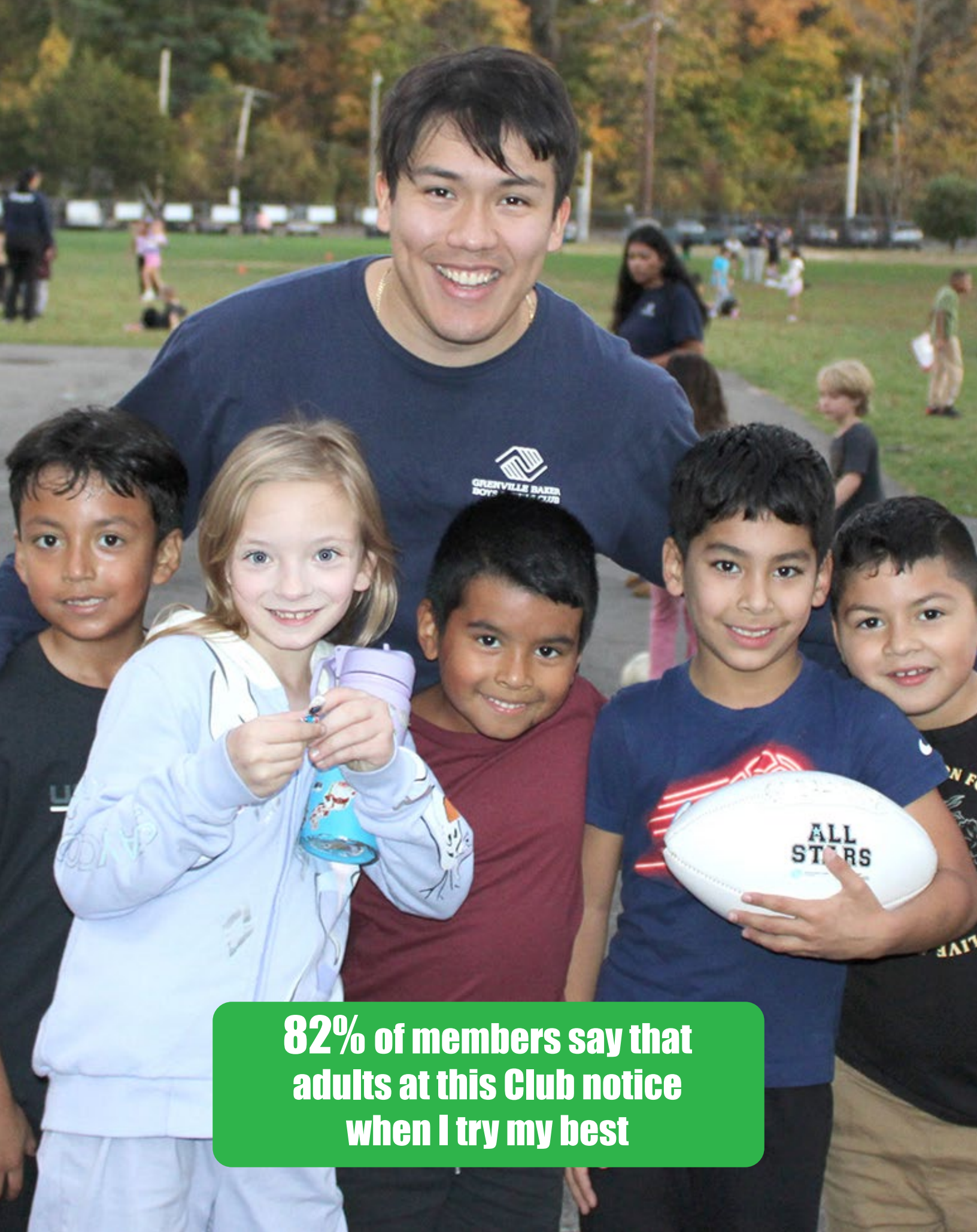
Total Operating Revenue
